Fulton County Sheriff's Office Arrests Theft Suspect

Atlanta, GA – The Fulton County Sheriff's Office, Criminal Investigations Division, Fugitive Apprehension Support Team (FAST) arrested Trevon Bonner, age 23, of Atlanta, for one count of theft by receiving stolen property. He is currently in the Fulton County Jail.

FAST received a tip that Cody Glisson, of Macon, GA, posted a 2022 Kawaski 450 motorcycle on Facebook Marketplace. On April 14, 2024, in broad daylight and in a business parking lot in Lake City, Clayton County, GA, Glisson met with a potential buyer by the name of "Herbert Caddle," according to his Facebook profile. "Caddle" asked Glisson if he could test ride the bike inside the parking lot and Glisson agreed. "Caddle" sat on the bike and rode directly out of the parking lot and never returned.

The following day, Glisson saw what he believed was his stolen bike listed for sale on Facebook Marketplace. The Facebook account was newly created under the name "Jeremy Foster." Glisson, in coordination with the Fulton County Sheriff's Office, posed as a potential buyer for the bike and arranged to meet with "Foster" at the Rosel Fann Recreation Center in Atlanta, GA.

When "Foster" arrived, he was met by the Fulton County Sheriff's Office and arrested. "Foster" was positively identified as Trevon Bonner. It is suspected that Bonner is also "Caddle," who had stolen the bike from Glisson on the previous day. This is an active investigation, and additional charges are pending.

The FCSO K9 Unit also assisted in this arrest.

"I am proud of the women and men of the Fulton County Sheriff's Office who are committed to fighting crime within Fulton County," says Sheriff Patrick "Pat" Labat. "Online scams can unfortunately be quite common. It is crucial for Fulton County citizens to remain vigilant and cautious when buying or selling items online."
